

## LARGE CAP SHARE BUYBACK FUND

The Fund seeks growth of capital by investing primarily in the common stocks of large domestic companies that have engaged in a share repurchase program in the last twelve months.

This Fund is suitable for investors who:

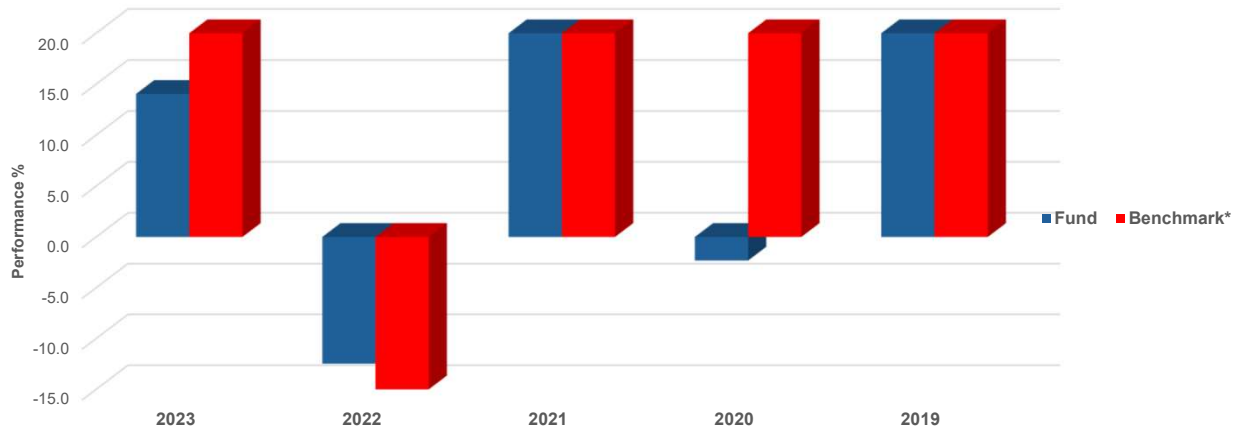
- seek higher long term capital gain appreciation;

### INVESTMENT STRATEGY

The Fund takes advantage of the "share buyback anomaly" by owning large cap domestic stocks that have purchased their own stock over the last trailing twelve months or have announced significant share buy back programs. The Fund is rebalanced periodically to an equal weighting between all the positions and is expected to hold between 40 to 80 names. Other factor considerations include recent financial performance, cash flow generation, balance sheet strength, and relative performance.

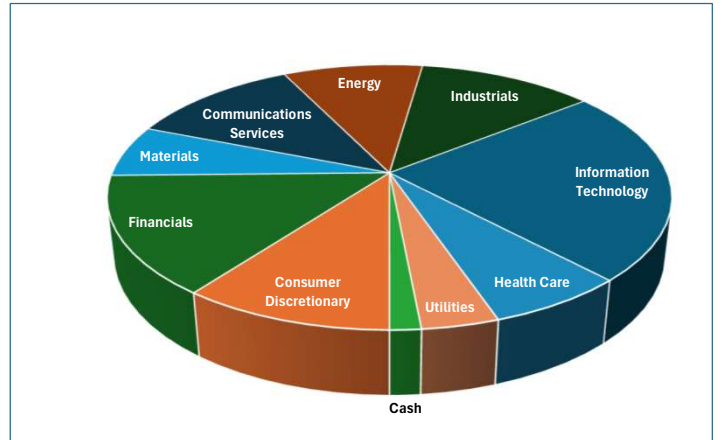
